
## **PITA Christmas Meet 2018 Report**



The PITA Christmas Meet and PITA AGM for 2018 were held jointly at the Smurfit premises of Kappa Hook. Townsend Last vear's meeting took place as Storm Caroline hit; this year's event coincided with the great Data Outage of O2, which affected a great many of us and was the lead story on the BBC News. Fortunately, we didn't need access to mobile data, emails etc, to enjoy the hospitality of Smurfit Kappa, who opened their doors to us on a mild but overcast day.

As with all good meetings, we started with refreshments and a chance to catch up with colleagues old and new. This initial part of the meeting was held in the new Experience Centre, which houses examples of the firm's product along with various bits of company information, past and present. (Smurfit Kappa is one of the largest multinationals in the paper sector, with manufacturing capacity of around 7Mt worldwide, so has a lot about which to be proud.)

After completing the formalities of the AGM (minutes appended below) the assembled group listened to a short presentation about the site, in particular its very recent history. If like me, you haven't visited Snodland for a large number of




years, it has changed out of all recognition. When I last visited in around 2006 it had two old brown machines (nominal width 4m), a fine paper machine producing twosided single coated high bulk paper, and converting plant. A year later the converting plant had gone, as had the coated operation (which never really sat well with Smurfit's core business). That left two small brown machines, producing together around 250,000tpy.











Move forward to 2013, and the company announced that the mill was to be reorganised yet again. The two old paper machines were to be closed and removed, and a single more modern and larger machine, obtained in 2010 from the assets of insolvent Italian company Cartiera di Cadidavid, would replace them. This machine was faster than those it replaced, more modern, and allowed lighterweight grades to be produced, thanks in part to the addition of a size press. Output tonnage remained similar, but quality improved.

After this presentation, given by Kevin Bussey (General Manager) we toured the machine house. Although the new machine is undoubtedly

the main change that has occurred recently, it is worth noting that Smurfit have been investing in other areas, notably in power production - a new CHP came online only in September.

Before we left there was a short Q&A session, then we departed. Thanks go to Smurfit Kappa (particularly Kevin Bussey) and the Smurfit Kappa crew who guided us around. Also, it is worth noting that visits are a two-way affair, and require the visitors as well as a host: in particular this event drew parties from as far afield as the South West (Somerset) and North West (Lancashire / Cumbria). An equal vote of thanks go to all who made such long journeys to be present. See you again next year!
